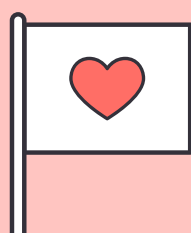


DISTRICT ADMINISTRATION: A LEADING RESOURCE FOR ADMINISTRATION DATA

WHAT IS THE CARE ACT?



The CARES Act provides fast and direct economic assistance for American workers and families, small businesses, and preserves jobs for American industries.

THE PURPOSE OF THE CARE ACT



This over \$2 trillion economic relief package delivers on the Trump Administration's commitment to protecting the American people from the **public health and economic impacts** of COVID-19.

FUNDING THE CARE ACT



The Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed by Congress with overwhelming, bipartisan support and signed into law by President Trump on **March 27th, 2020**.

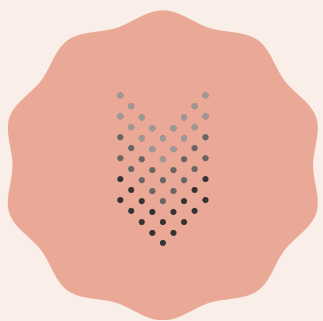
\$30.75 BILLION FOR AN EDUCATION STABILIZATION FUND

\$30.75 BILLION FOR AN EDUCATION STABILIZATION FUND HAS BEEN ALLOCATED OVER 4 GRANT PROGRAMS:



1. EDUCATION STABILIZATION FUND DISCRETIONARY GRANTS

Congress set aside **1% of the \$30.75 billion** allotted to the Education Stabilization Fund for grants to **States** with the **highest coronavirus burden** (through two separate grant competitions).



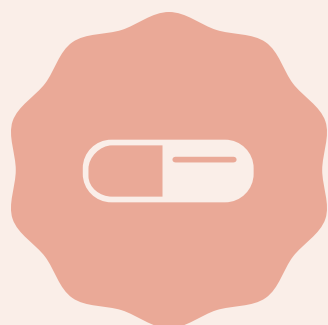
2. GOVERNOR'S EMERGENCY EDUCATION RELIEF FUND (GEERF)

Congress set aside approximately **\$3 billion** of the **\$30.75 billion** allotted to the Education Stabilization Fund for the GEERF. The Department will award these grants to States (governor's offices) based on a formula.



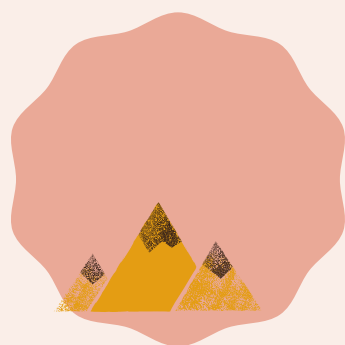
(1) 60% on the basis of the State's relative population of individuals aged 5 -24.

(2) 40% on the basis of the State's relative number of children counted under section 1124(c) of the Elementary and Secondary Education Act of 1965 (ESEA).



3. ELEMENTARY AND SECONDARY SCHOOL EMERGENCY RELIEF (ESSER) FUND

Congress set aside approximately **\$13.2 billion** of the **\$30.75 billion** allotted to the Education Stabilization Fund for the ESSER Fund. The Department will award these grants to State educational agencies (SEAs) for the purpose of providing local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that COVID-19 has had on schools.



4. THE HIGHER EDUCATION EMERGENCY RELIEF FUND

FORMULA GRANTS TO THE OUTLYING AREAS

Congress set aside **one-half of 1% of the \$30.75 billion** allotted to the Education Stabilization Fund for formula grants to the Outlying Areas of the United States, specifically: *the US Virgin Islands (VI), Guam (GU), the Commonwealth of the Northern Mariana Islands (CNMI), and American Samoa (AS)*. Money made available from these grants will be calculated via formula.

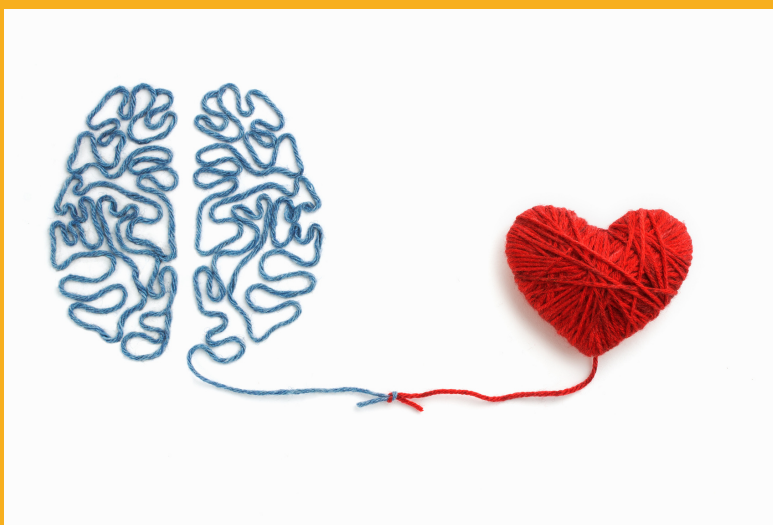
